**EXEMPT LICENSE PLATE APPLICATION** 

NRS 482.268, 482.368, 482.429 & 371.100

Exempt vehicles are not subject to Governmental Services Taxes and may qualify for distinguishing exempt license plates OR, upon proper application and justification, exempt vehicles may qualify for license plates not bearing any distinguishing mark which would serve to identify the vehicles as owned by the State, county, or city (standard issue plates) pursuant to **NRS 482.368**.

## **Exempt Plates Distinguished with EX:**

Vehicles which are exempt pursuant to *NRS (371.100)* may request EX distinguished plates. Qualifying exempt vehicle types include vehicles owned by the United States, the State of Nevada, a political subdivision of Nevada, any county, municipal corporation, city, unincorporated town, or school district in the State of Nevada; vehicles funded with State or Federal money solely for services to elderly or handicapped persons, and Emergency vehicles owned by any volunteer fire or ambulance service in Nevada.

**Exempt Plates Without Distinguishing Mark (Standard License Plates):** Vehicles which are exempt pursuant to **NRS 482.368** may request exempt standard license plates not bearing any distinguishing mark. Qualifying exempt vehicle types include vehicles maintained, used by or under the authority and direction of a city, county, or state agency for the purposes of law enforcement, if authorized by the Department with <u>proper application and justification.</u>
