STANDARD HORSELESS CARRAIGE LICENSE PLATES NRS 482.380

All applications must be stamped or otherwise validated by the Horseless Carriage Club of Nevada

Standard Horseless Carriage license plates may be issued to a person who has resided in the State of Nevada for a period of 6 months preceding the date of application for the license plates and who owns a vehicle which is a model manufactured during or before 1915.

The applicant must:

- 1. Present evidence of his eligibility for license plates by showing residence in the state for 6 months preceding the date of application and ownership of an antique motor vehicle which is a model manufactured during or before 1915.
- 2. Present a certificate of inspection issued by the Horseless Carriage Club of Nevada,
- 3. Present a valid driver's license,
- 4. Pay such other fee as prescribed by the Horseless Carriage Club of Nevada, and
- 5. Pay the fee for the plate.
 The initial fee is \$35. There is annual renewal fee of \$10.

These fees are in addition to all other applicable fees (Vehicle Registration, Prison Industry Fee, Government Services Tax, Supplemental Government Services Tax in applicable counties.
