- [Establishment of a \\$3 license plate production fee](#) pursuant to the passage of AB 473 in the 2013 Legislative Session.
- [Establishment of a \\$20 fee](#) for an expedited certificate of vehicle title, and a \$20 fee for an expedited title that does not include prepaid postage pursuant to the passage of AB 309 in the 2013 Legislative Session.
- [Establishment of a \\$6 fee](#) to defray the cost of an identifying device (IFTA decal) issued pursuant to the passage of AB 464 in the 2013 Legislative Session.
