#### Review of Nevada Legislature Signed Bills as it Relates to the Board

#### Discussion on Senate Bill 29

- Dick Mills (Wreckers); Allow 3<sup>rd</sup> party to print salvage title. Scheduled to go into effect October 1<sup>st</sup>.
- JD Decker (DMV/CED); This is a Central Services bill. They are working on it. They are working on having 3<sup>rd</sup> party certification.
- Dawn Bobbert (Insurers); Questions if it has any effect on accepting e signatures.
- JD Decker (DMV/CED; Answers that they are not related.
- Dick Mills (Wreckers); How long does it get fingerprints back?
- JD Decker (DMV/CED); That depends on DPS and FBI. The department has no control over the timeframe.
- Michelle McClellan (Salvage Pools); Does the department have the forms ready for October 1st.
- Dick Mills (Wreckers); There is not a process ready yet.

#### Discussion on Assembly Bill 32

- JD Decker (DMV/CED); This is another Central Services bill that covers tow companies.
- Ivie Hatt (DMV/CED); In the DMV's website under notices there are all the workshops and hearings for all department's bills.

#### Discussion on Assembly Bill 349

- Dick Mills (Wreckers); Is this a smog Bill?
- Ivie Hatt (DMV/CED); It is not a smog Bill. It is more of an insurance and registration Bill on classic vehicles. It also exempts the emissions test for an additional year for new vehicles, from three to four years. It also lowers the association fee for emission stations.
